1. **WARRANTY:** Joneca Corporation warrants this Ready Hot Instant Hot Water Dispenser and/or Faucet, when installed in the United States or Canada, to be free from defects in workmanship and material during the warranty period. This warranty sets forth our overall warranty commitment. We will not assume, nor authorize any person to assume for us, any other liability in connection with the sale of our products.
2. **LENGTH OF WARRANTY:** Model RH-100 - One year from date of purchase; Model RH-200-SS - Three years from date of purchase. Model RH-300 - Three years from the date of purchase. Models RH-F570-CH and RH-F570-BN Single Lever Faucet – One year from date of purchase. Models RH-F560-CH and RH-F560-BN Dual Lever Faucet– One year from the date of purchase. Models RH-F550-CH and RH-F550-BN Three Way Faucet – One year from date of purchase. Any model that fails to operate during its warranty period, will be either repaired or replaced at the discretion of Joneca Corporation. Original sales receipt required.
3. **DEFECTIVE DISPENSER AND/OR FAUCET:** During the warranty period, a defective or inoperative dispenser and/or faucet will be replaced by the company at no charge to the consumer/purchaser. Service or labor charges are not included. Original sales receipt required.
4. **CHANGE OF OWNERSHIP DISPENSER:** This warranty is limited to the original purchaser. Warranty remains in force for warranty period from date of purchase of dispenser by the original retail customer. Original sales receipt required.
5. **MISUSE OF DISPENSER AND/OR FAUCET:** This warranty does not apply to any dispenser and/or faucet which is misused, altered, improperly installed or used for anything other than normal residential use. Additional conditions are not covered by the warranty as follows: Electrical connections due to improper installation; connecting to an incorrect faucet type; use with an empty dispenser tank; connecting to an improper electrical outlet; use of harsh cleansers and solvents.
